

## **Exhibition of Vehicles with thermal propulsion in SQUARE**

The exhibition of motor vehicles with thermal propulsion are allowed provided that:

- The tank contains only max 5l of fuel
- The battery must be disconnected
- The keys must be handed over to the security for possible evacuation
- The most direct access possible to the outside (without having to move furniture, stands, etc.) must be left free in case the vehicle (s) needs to be evacuated. The exhibitor will give SQUARE's security service the necessary means to move the vehicle in case of emergency (.... keys, codes, security, etc.)
- The agreement of SQUARE's security manager is required to take the necessary security measures.

The prohibition of the use of gas in GHs (Grands Halls) is similar and is also applicable to machinery or vehicles.

The maximum admissible height of the vehicle is 2m.

# **EXHIBITION OF HYBRID VEHICLES IN SQUARE**

In application of our insurance obligations and pending a favorable opinion from Siamu (Brussels's Fire Brigade and Emergency Medical Service), the maximum energy present in the batteries on board the vehicle will be MAXIMUM 30 of the total capacity and the fuel tank will contain a maximum of 5L of fuel.

- The most direct access possible to the outside (without having to move furniture, stands, etc.) must be left free in case the vehicle (s) needs to be evacuated. The exhibitor will give SQUARE's security service the necessary means to move the vehicle in case of emergency (.... keys, codes, security, etc.)
- The agreement of SQUARE's security manager is mandatory in order to take the necessary security necessary security measures and to validate the location on plans.

In addition, these vehicles are usually made of composite materials that generate toxic fumes.

Due to the weight of these vehicles, distribution plates are required and needs to be approved by SQUARE.

Pending technical solutions, it is therefore forbidden to bring this type of vehicle into SQUARE without specific authorization from SQUARE: <a href="mailto:dominique.meurant@square-brussels.com">dominique.meurant@square-brussels.com</a>

#### **Electric VEHICLES**

In view of the possible risks associated with the batteries of these vehicles, each request will be specifically examined in relation to the customer to ensure safety in SQUARE. A file containing the vehicle's technical data sheet and a plan for implementation in SQUARE will be required. SQUARE reserves the right to refuse to display an electric vehicle in these buildings.

### **EXHIBITION OF VEHICLES ON THE OUTSIDE SLAB ABOVE THE STAIRS OF THE CUBE**

The display of vehicles on the SQUARE slab must remain exceptional and require the written agreement of SQUARE and the possible agreement of the Brussels authorities by virtue of an agreement signed with the City.

Since advertising for vehicles is prohibited in the Brussels region, it is not permitted to place beach flags or any other advertising panel with the **brand name** (Mercedes, Audi, etc.) of one or more manufacturers. On the other hand, a communication can be placed in the direct surroundings of the exhibition but without mentioning car brands.
